NOTICE IN TERMS OF SECTION 116(3) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 (ACT 56 OF 2003) FOR THE EXTENSION OF PROFESSIONAL FEES BEYOND 20% FOR MAKGERU-SCHOONOORD BWS PROJECT – 2023/24 (GSDM07/08/2005).

Notice is hereby given in terms of Section 116(3) (a) and (b) of the Local Government Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Sekhukhune District Municipality to extend the professional fees beyond 20% for Makgeru-Schoonoord BWS project.

Reasons for the proposed extension: due to several delays caused by community unrest and also procurement of materials resulting in slow progress on the project and in some instance led to stoppage of work, the project could not be completed on the stipulated time. Such delays has led to several extensions on the project which necessitated also the extensions of supervision costs for the professional service provider (consultant). The project is currently at 95% completion and it is being implemented as per the original scope. It is in the best interest for the municipality to proceed with the current service provider to provide supervision on the remaining scope of work to achieve practical completion on the project.

It is therefore not practical or cost effective for Sekhukhune District Municipality to appoint a new service provider for what is merely a continuation of the ongoing project.

Notice is hereby further given in terms of Section 21 and 21A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) that the local community and interested/affected parties are invited to submit comments or representations to the Municipality in respect of the above, such comments or representations must be received within 14 days of advertisement via electronic mail to the e-mail address provided below, or be delivered to the undersigned to the mailing address provided hereunder.
