**NOTICE IS HEREBY GIVEN** in terms of Section 33 of the Local Government: Municipal Finance Management Act, No. 56 of 2003 that Sekhukhune District Municipality (SDM) intends entering into contract relating to the provision of management, operation and maintenance and capacity building in respect of bulk water schemes through an outsourced mechanism for a period of ten (10) years in respect of water bulk water schemes owned by SDM. The contract will impose financial obligations on the Municipality for a period longer than three (3) years covered in the annual budget for the financial year 2016/17.

**NOTICE IS FURTHER GIVEN** in accordance with Section 21A and Section 21 of the Local Government Municipal Systems Act, No. 32 of 2000 and Section 19 of the Water Services Act, No.108 of 1997 that-
