1. Executive Summary

A. Liquidity Measurement

The current ratio is measuring the short-term solvency of the municipality. It measures the extent to which the municipality's current assets covers its current liabilities. The ratio format divides the total current assets by the total current liabilities as at the time of reporting and the norm is that the municipality's current assets will cover its current liabilities by the norm range between 1.5 to 2:1 as per MFMA Circular no.71.

The ratio computation was as follows:

Current Assets/Current Liabilities (1 113 783 616/690 249 904) = 1.61

The municipality's current ratio is within the norm range of between 1.5 to 2:1 as at the end of 3rd Quarter 2024/25, the cash and short-term investments balances contributed quite significantly to the unfavourable current ratio for this period with a combined closing balance of R 714 295 249.

Acid-Test Ratio

The acid-test ratio compares the municipality's "quick assets" (cash and accounts receivable) to its current liabilities. It is used to determine short-term liquidity of the municipality. The ratio format considers the total current assets less inventory items which will normally be difficult to liquidate though the municipality is not trading entity and divide by the total current assets as at the reporting date with a good ratio considered to be 1:1 as a norm.

B. Cash Flow and Investment Management

The municipality's primary bank account closed with a positive balance of about R 54 939 236.76 and short-term investments closed at R659 356 012.66. The combined interest earned on short investment amounts to R 4 266 523.36 as at end of 3rd Quarter 2024/25.

Net cash flows from operating activities amounts to a positive R 757 341 100.04 as at end of 3rd Quarter 2024/25, net cash flows from investing activities amounts to R 595 737 909.52 and net increase in cash held amounts to R 161 603 190 as at 31st March 2025.

C. Expenditure management

The total invoices received from suppliers were 740 during the 3rd Quarter, 582 invoices at a total rand value of R 283 710 221.80 were processed and paid, 158 invoices were in progress as at 31st March 2025.

R 307 631 992.70 in purchase orders, R 476 960.33 in sundry purchases, R 108 149 662.30 in capital projects and R 25 580 393.14 in 3rd party payments were processed as at end of 3rd Quarter 2024/25, totalling R 441 839 009.02.

The municipality incurred an expenditure to an amount of R 313 382 460.05 on employee related costs as at end of 3rd Quarter 2024/25.

Expenditure on council remuneration was R 12 579 909.47 as at 31st March 2025.

Depreciation on non-current assets was R 69 022 563.

R 359 812 907 was the expenditure on contracted services as at 31st March 2025. Contracted services include amongst others the security services operational fleet expenses, photocopying machines and vehicle tracking services.

Expenditure on transfers and subsidies was R 8 771 103.60 as at end of 3rd Quarter 2024/25.

R 180 067 203.52 was the expenditure on other operations expenditure programmes.

Financial ratios on operational expenditure:

(i) Employee related cost as % of total operational expenditure:

Norm is between 25% – 40%

(Employee related cost/Total operational Expenditure) x 100 (R 313 382 460.52/R 1 022 070 218.47) x 100 = 31.88% (27% in the 2^{nd} quarter of the 2024/25 financial year)

The municipality has incurred in total R 313 382 460.05 in employee related costs as at end of the quarter. The expenditure incurred amounts to 27% of the total operational expenditure as at end of the quarter.

(ii) Contracted services as a % of total operational expenditure:

Norm is between 2% - 5%

(Contracted services/Total operational expenditure) x 100 (R 359 812 907.41/ R 1 022 070 218.47) x 100 = 35.20% (21% in the 2^{nd} quarter of the 2024/25 financial year)

The expenditure on contracted services is currently above the 5% required norm on contracted services currently include amongst others the security services operating leases on office buildings and photocopying machinery and municipal fleet.

(iii) Capital expenditure budget implementation indicator:

Norm is between 95% - 100%

(Actual capital expenditure/Budgeted capital expenditure) x 100 (R 317 608 432.20/ R 526 053 378.40) x 100 = 60.38% (77% in the 2nd quarter of the 2024/25 financial year)

(iv) Operating expenditure budget implementation indicator:

Norm is between 95% - 100%

 $(R 1 022 070 218.47/R 976 786 717.40) \times 100 = 104.64\% (130\% in the 2nd quarter of the 2024/25 financial year)$

Implementation on the operational expenditure budget was at 104.64% as at end of third quarter.

D. Revenue management

A total of 20 029 water meter readings were captured during the 3rd Quarter 2024/25. 20 407 readings were captured during the 2nd quarter of the current financial year.

Total revenue billing on water and sanitation services was reported at R 35 572 284.38 for the 3rd Quarter (R 42 560 538.50 in the previous quarter). R 13 383 532.30 was the total collection on own revenue for the 3rd Quarter (38% collection rate), a decline from the 47% collection rate reported in the 1st quarter of the financial year.

The appointment of the smart pre-paid water metering was concluded in December 2024. The introductory meeting held virtually in December 2024.

The plan to implement the installation and maintenance of the smart water meters is outlined as follows in a process flow:

- The business community has been identified as the targeted customer group for piloting purposes.
- Greater FetakgomoTubatse will be our first area for installations given the larger business community in the area.
- Elias Motsoaledi will be second, followed by Ephraim Mogale and lastly Makhuduthamaga.
- Government departments will be second in terms of the targeted customer group for installations.

- Awareness was activities initiated during the 3rd quarter, activities to continue in the 4th quarter.
- The audit of the site identified for piloting was conducted in March 2025 around Burgersfort area.
- Households will be the third and last targeted customer group for installations with about 14 areas already identified for potential revenue growth.
- Installation of the bulk smart water meters at all off take points operated by the Lepelle Northern Water and some of the residential estates already identified.

The following processes will unfold during the implementation of the smart water metering:

- Establishment of satellite offices in each sub region as our technical support centre.
- Local municipal offices are to be used as satellite offices, Tubatse & Ephraim Mogale office spaces already secured.
- Training of staff and awareness campaigns to customers on how to utilise the new smart water meter system and request support.
- Establishment of a call centre facility for technical support.
- Installation of the vending points in various convenient stores.
- A one-month trial period is to be implemented in FetakgomoTubatse to test the efficiency of the system.

The municipality did continue with the implementation of the credit control policy during the 3rd quarter of the current financial year.

E. Supply Chain management

The following processes of procurement were implemented as at end of 3rd Quarter 2024/25:

- (i) Purchase orders equal or less than R 30 000 VAT Inclusive:
 - 340 Quotations to a total rand value of R4 143 225.76 were processed for the procurement of goods and services.
- (ii) Purchase orders more than R 30 000 but less than R 200 000 VAT Inclusive:
 - 188 Quotations to a total rand value of R 17 841 386.26 were processed for the procurement of goods and services.
- (iii) Purchase orders more than R 200 000 VAT Inclusive:
 - 208 orders with a total rand value of R271 135 555.45 were processed.

The following 51 competitive bidding processes were also implemented as at end of 3rd Quarter 2024/25:

(i) 50 requisitions of goods and services through the competitive bidding processes. 32 were adjudicated and awarded. 4 readvertised, 14 in progress and 1 withdrawn

The unauthorized irregular, fruitless and wasteful expenditure was within the norm in terms of percentage thought an amount of R 24 419 648.31 was incurred as fruitless and wasteful expenditure during the quarter, the user department is currently investigating this expenditure. The increased UIFW from the amounts reported in the previous quarter is noted that no amount is to be incurred as fruitless and wasteful hence corrective measures were implemented to remedy the root causes of the expenditure incurred during the fourth quarter.

R 254 856 was the total rand value for all deviations during the 3rd quarter of the financial year, R254 856 of this amount was recorded during the month of March 2025. Deviations were for services procured through processes where it was very impractical for the institution to follow the normal procurement processes.

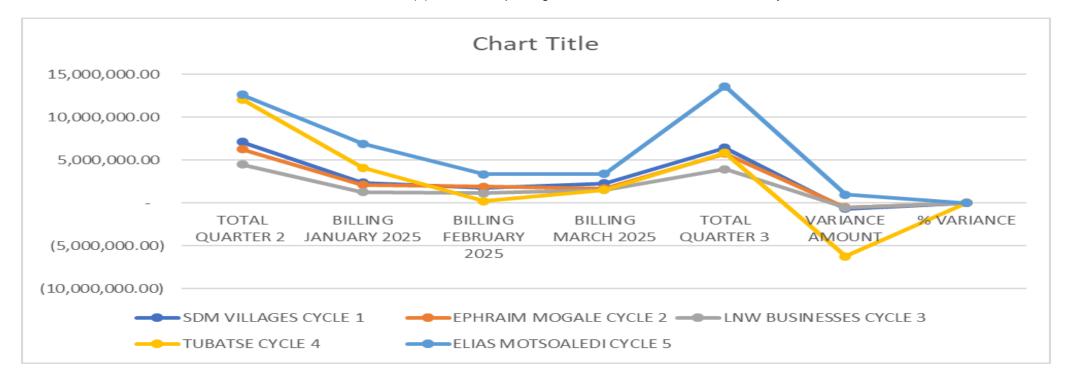

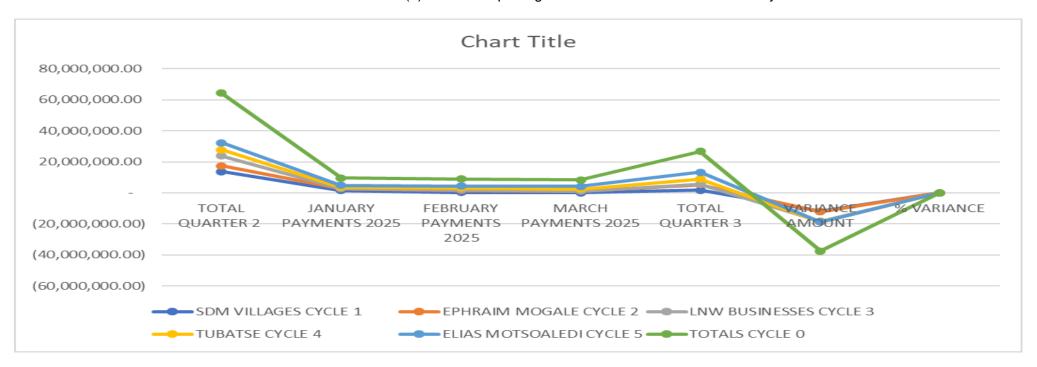
